Presidents Report

The CYCEAB was incorporated in 2012 and held its first AGM in October. We undertook a significant membership drive in conjunction with the first AGM by adjusting our by-laws to offer founding memberships that did not require that members would be accredited. This provided us with additional members to assist with the work of the Board as well as the necessary capital to undertake some of that work. We have 30 institutional members, of which 25 are educational institutions. We hope to recruit additional members as well as retain our current membership into our next year.

It has been a busy year and working strictly on volunteer

time we have finalized our Accreditation Standards. We have created a public presence through our website and we have requested proposals to assist us with the development of the materials necessary to enable educational programs to undertake an actual accreditation.

It is a privilege and an honour to work with the Board of Directors for this organization. The Board has created a model of accreditation that is unique to Child and Youth Care. We have worked to prioritize our activities to meet the goal of being ready to accept full members who want to engage in the Accreditation process by 2016.

I invite members to get involved and to contribute to shaping the content and process of accreditation. Founding membership is only available for 2 more years because we hope to be able to fully accredit programs by the beginning of 2016. It is an ambitious agenda. Please join us.

While I will continue with the Board in the second year of a 2 year term, I have decided not to continue as president. We have a highly capable Board and I'm confident that the Executive and the Board will continue to grow this process and remain true to the values and intent of Child and Youth Care Practice.

History of the CYCEA

The task force on Child and Youth Care Educational Accreditation was created in 2006 at the request of Canadian child and youth care educators who attended the International CYC conference in Montreal. The task force was co-chaired by

Carol Stuart and Roy Ferguson. A flexible model of accreditation for post-secondary Child and Youth Care programs in Canada was suggested as a mechanism to further the work of enhancing quality of care and service for children, youth

and families in need of social, educational, and health interventions. The Task Force was initiated to follow-up the work of the Canadian Council of Child and Youth Care Associations on professional regulation. The Council held regular meetings of educa-

tors, practitioners, and managers at national and international conferences in 2000, 2002, 2004, where professional regulation was discussed. The development of a substantive proposal and accreditation model occurred in 2008, and the Task Force final-

ized its recommendations at National CYC Conference in May 2010.

Task force recommendations outlined the mission and principles of child and youth care accreditation and recommended the formation of a founding board and incorporation. The

principles of inclusiveness, engagement, reflective practice, and commitment to quality run throughout the report of the task force and have been carried forward by the founding board, who were elected from among the group that attended the 2010 conference.

The principles of inclusiveness, engagement, reflective practice, and commitment to quality form the foundation of the work of the CYCEA Board of Canada.

Policies and Procedures Committee

The Child and Youth Care Educational Accreditation Board of Canada formed a committee in June 2013 to begin developing policies and procedures. The committee is seeking membership as we move forward in this process.

Standards and Implementation Committee



Over the past 12 months the Standards committee has met several times and worked diligently in between meetings in order to present a final version of the Outcomes Assessment Accreditation Standards Model to the board for approval. The Standards committee has been very active with input from Child and Youth Care faculty from across the country as well as from CYCEAB board members. The finalizing of the Accreditation Model was an essential element for our continued move forward.

In June 2013 during our board meeting in St. John's Newfoundland the CYCEAB of Canada voted to accept the Outcomes Assessment Accreditation Standards Model as presented. This model can be viewed on the website www.cycaccreditation.ca

At that time it was also decided that the Standards Committee would change its purpose to become

the Development and Implementation Committee with focus on supporting the development of the tools and documents needed to implement the Accreditation Model as developed.

The request for proposals was sent out and a deadline for proposal submissions was set for October 30, 2013. The committee will be involved in supporting the executive committee in selecting a proposal and moving the next steps towards an Accreditation process that is ready to be implemented.

The amount of work that this committee accomplished over the past year is worthy of celebration. It has been a privilege to be involved with this group of dedicated Child and Youth Care Practitioners.


Planning and Priorities
