Preliminary Investigation into Field Work Models in Canadian Child and Youth Care Education

Overview

Field work, placement, practicum... these are some of the names used to describe field experience necessary when obtaining a credential in Child and Youth Care (CYC). While it could be agreed that practicum education is important in this field, there is an absence of research specific to CYC. This investigation will explore and report key variables of the various CYC field work (FW) models used across Canada, which includes practicum structure, supervision and evaluation. As this is a preliminary study of field work in CYC education and is only a snapshot of CYC field work models, to attain a better understanding of this important component of CYC education, there is a need for further research.

Method

The practicum practices of 28 CYC programs across Canada were explored using data collected by Mike Keough for his Masters research project entitled: "Practicum Education in Child and Youth Care", and email correspondence with program faculty. As the data from this project was collected for the 2014-2015 academic year, email correspondence and online searches were conducted to update existing information to the 2015-2016 academic year. Although the data collected is public information, all participating institutions have been coded with an individual ID based on region and credential and will be discussed by code throughout this report.

Analysis

CYC Program Location

Participating institutions include: Algonquin College, Cambrian College, Confederation College, Douglas College, Eastern College, Sir Sanford Fleming College, George Brown College, Grant



- MacEwan University, Humber College, Lethbridge, Mohawk College, Mount Royal University, Nova Scotia Community College, Seneca College, Sheridan College, St. Clair College, University of Fraser Valley, University of Victoria and Vancouver Island University.
- > The regions were divided into 3 parts:
 - o Western Canada consist of programs in British Columbia and Alberta
 - Central Canada include those in Ontario
 - Eastern Canada include those in New Brunswick and Nova Scotia

Over half (54%) ot the CYC programs were found across Ontario, over a third (36%) were in Western Canada and at 11%, Eastern Canada made up of the lowest number of programs (figure 1).

Program Credentials

There are four types of credentials that exist for CYC, which consist of accelerated advanced diplomas (Acc. Dip), diplomas (Dip), advanced diplomas (Adv. Dip) and degrees (Deg). The length of the program ranges from 1 to 4 years. Figure 2 includes the proportion of participants, a summary of the program length and locations by credentials.

Accelerated Advanced Diploma Program

For programs that have a length of 3 semesters, the first two semesters consist of solely course work and the final semester is practicum. For those with four (4) semesters, there is a practicum starting in semester two (2). 02A02 and 02A03 are located in the Greater Toronto Area (GTA) and follow a 16 month / four (4) semester format, whereas 02A01 and 02A04 are located outside of the GTA and follow a one (1) year / three (3) semester format.

Diploma Program

01B02 and 01B03 do not follow a curriculum in a semester format. The programs duration ranges from 69 to 76 weeks, including 6 weeks of break scattered throughout. The majority of programs have a CYC designation upon completion of the program except for the following:

- > 03B01 has a title of CYCC
- > 01B02 has a title of CYCW
- > 01B03 has a title of CYCW with Addiction's Support

Advanced Diploma Program

While most are a 3 year / 6 semester program, there are 2 programs that are different:

- > 02C10 is 3 years with 9 semesters
- > 02C02 is 2 years with 6 consecutive as they are consecutive semesters.

Similar to the Accelerated Advanced Diploma programs, half of them are located in the GTA.

Degree Program

All program have a designation of BA-CYC except for the following:

- > 03D06 has a BCST-CYCC Major
- > 03D05 and 02D01 have a BCYC

Structure Figure 2

The structure of CYC field work is made up of various components and include the total number of practicum, model, first practicum characteristics, total hours and the comparison between hours and credits. Each item will be explored as a whole and then further broken down by credential.

Total Number of Practicum

Overall All Programs

The total number of practicum ranged from 1 to 6. Most programs (39%) have 3 practicums, 25% have 2 practicums, 18% have 4 practicums, 11% have 1 practicum and 7% have 6 practicums as seen in figure 3.

Four programs report offering an additional specialized certification option outside the curriculum, but students still participate within the program placement structure.






Group practicum experiences were included in this count as a distinct practicum but this may change upon on curriculum revision. When comparing to all programs, there is a spurious relationship in the length of the program and the total number of practicum in CYC, as those with two or less practicums are from various credentials. This relationship is further explored by credentials.

Accelerated Advanced Diploma Program

The number of practicum allotted for accelerated diploma ranged from one to three practicum as shown in figure 4.


2 programs had 1 practicum (50%)



- 1 program had 2 practicums (25%)
- 1 program had 3 practicums (25%)

It is interesting to note that the programs with only 1 practicum are those who have only 3 semesters.

Diploma Program



The number of practicum allotted for diploma program was quite variable as shown in figure 5.

- > 1 program had 1 practicum (14%)
- > 1 program had 2 practicum (14%)
- > 3 programs had 3 practicum (43%)
- 2 programs had 4 practicum (29%)

It is interesting that although all diploma programs offer two years of study over four semesters, field work models within these programs vary considerably.

Advanced Diploma



The number of practicum allotted for advanced diploma was at minimum 2 practicums as shown in figure 6.

- > 3 programs had 2 practicums (30%)
- > 5 programs had 3 practicums (50%)
- 2 programs had 4 practicums (29%)

There was no association with the length of program and the total number of practicum given that programs with 2

practicum did not only include 02C02, which is 2 years in length, but two others, which are 3 year programs.



The number of practicum for degree programs ranged between 2 to 6 as shown in figure 7.

- ➤ There are 2 programs each for those with 2, 3 and 6 practicums.
 - Only 1 program had 4 practicums

One program had additional practicums that did not take place in a front-line setting. Those with practicums that continued for multiple semesters were considered as one practicum, as one set of credits and hours were assigned.

Three degrees had specialized practicum including:

- > Specialization in Working with the First Peoples of this land.
- Child Protection Specialization, which is a block placement, or a Child Life Specialization, which is longer practicum. The option of doing these after graduating as a Post-Degree Certificate of Extended Studies is available.
- Child Protection Specialization as a block placement in 4th year.

Model

Practicum can be concurrent, block or a variation of block and concurrent. Concurrent practicums take place simultaneously with other courses, whereas block practicums occur in a semester that students are not taking other courses. A variation occurs when practicums begin as a block, but later in the semester continue as concurrent.

Overall Program Practicum analysis

Of the 82 practicum reported, the most common type of practicum is concurrent with 43%, and the frequency of block and the variation were nearly even at 29% and 28% respectively.

Practicums tend to begin as concurrent model. Variations of block and concurrent are popular in later placements, and shift to mostly block in the third experience (figure 8).

Concurrent practicums begin at 61% and then decrease to 29% in third placement. Whereas block practicums begin at 25% and then increase to 53% in third placement. It was most common to see a variation of block and concurrent in the second practicum experience. As there were only two programs that offer a fifth and sixth practicum, the proportion is rather skewed in comparison to programs with up to 4 practicums. Below is a full breakdown of the percentage of practicum types by practicum number.




Accelerated Advanced Diploma



There were a total of 7 practicums across all four programs. 43% of all practicum were concurrent, and near equal proportion of block and a variation (28% and 29%) (figure 9).





Figure 10 Programs with 1 practicum were block practicum.

Only 1 program (02A03) offers solely multiple concurrent practicums. There was a shift towards concurrent practicum as total practicum increased, while there was no variation found in third practicum (figure 10).

Diploma Program



Across all seven programs, a total of 20 practicums were found. To note, only 18 were classified as the other 2 were group practicum.

More than half of the practicums (55%) were block, 25% were concurrent and 20% were a variation of block and concurrent (figure 11).

Concurrent practicum were only found in the first and second practicum and shift to either variation or block at subsequent practicum. This does not apply to 03B02, which offers only a sole concurrent practicum that spans two semesters. When a program has a 3rd or 4th practicum, they are only block practicum or a variation (figure 12). Below is a chart of the full breakdown by practicum.





Advanced Diploma Program



For the ten Advanced Diploma programs, there was a total of 29 practicums. More than half of the practicums (55%) were concurrent, 35% were block and 10% were a variation of block and concurrent (figure 13).

The majority of the first 2 practicums were concurrent with equal distribution of practicums that were block. As a third practicum is introduced, it appeared to shift towards block. However, for the only 2 programs that offered a fourth practicum, they were only concurrent (figure 14).





Degree Program



There were a total of 26 practicums across all degree programs. About half were either concurrent (54%) or a variation of block and concurrent (42%), and 4% of practicums were block (figure 15).



As a student enters a third practicum, it appears to shift to

block or a variation of block and concurrent (figure 16). Degree programs that had concurrent programs did not have any block practicum. Below is a chart of the percentage of practicum types by practicum.

First Practicum Characteristics

First Practicum experiences are particular noteworthy as there is frequently a difference when compared to later practicums. The practicum type varied across all credentials. The most common type of practicum was concurrent with 17 programs of the 28 (60%) and variations of block and concurrent was rarest with only 1 program from each credential. The hours ranged from 24 to 720 hours. Figure 17 summarizes the hour range across all credentials.

The occurrence of the first practicum was nearly unanimous across credentials, as almost programs (96%) begin first placement **after** the completion of at least 1 semester of academics.

- 3 programs offered a first placement in semester 1; two were from degrees and one from a diploma. One program indicated their first practicum was an on campus experience extending the learning outcomes of a course introducing students to concepts of advocacy.
- > 9 programs report first practicum is in semester 2.
- > 8 programs report semester 3.
- ➤ 4 programs report in both semesters 3 and or 4 as it is 1 practicum experience that spans for two semesters.

- > 2 programs do not begin practicums until third year in semesters 5 & 6 (both degrees).
- > Two diploma programs report in weeks not by academic semesters & were excluded.

Accelerated Advanced Diploma Program

First practicums begin either in the final semester (semester 3) or in semester 2. It was an even split between the 4 programs. Those with their first practicum in semester 3 were also only block practicum. Those in semester 2 were either concurrent or a variation of block and concurrent.

Diploma Program

First practicums most frequently began in semester 3 and were either block or a variation of block and concurrent. The program that begins in semester 1 and the one that occurs in semester 3 and 4 both offer a concurrent practicum.

Advanced Diploma Program

First practicums began mostly in semester 3 and were even distributed as either block or concurrent practicum. The two programs that begin in semester 2 offer only concurrent practicums, while the final 2 that occur in semester 3 and 4 had either concurrent or a variation.

Degree Program

First practicum in degree programs had the most variation, where it ranged from semester 1 to 5 and 6. There was only 1 program that had a variation of block and concurrent practicums and began in semester 2.

Total Hours

Overall for all programs, the hours ranged from 300 to 1440 hours. Figure 18 summarizes the total hour range across all credentials.

All programs except five demonstrated an increase in practicum hours from first placement to subsequent placements. All five offered two practicums, including 1 accelerated advanced diploma, 1 diploma, 2 advanced diploma and 1 degree.

Of the 18 programs offering more than 2 practicums:

- 1 decreased hours.
- 1 both increased and decreased hours.
- 6 remained the same.
- > 10 increased hours into more advanced practicum.

Credits and Hours Ratio

Typically, 3 credits for a course signify a particular set of hours for all academic courses. Yet, for practicum credits and hours in CYC programs, there are inconsistencies. Looking at 17 programs that reported both hours and credits, because of the high variability in those reported, the median value is provided. It was found that when academic course

hours are compared to practicum hours, the median was 55% for academic hours and 45% for practicum hours. When credits are compared, the ratio for academic value raised to 82%.

Although there is a large variability across CYC programs irrespective of credential, ultimately, the ratio of hours did not match to the credits allotted as seen in figure 19. Note

Practicum hours were considered distinct from Seminar hours, which in most programs were noted and calculated as part of academic credits.

Out of the 4 Accelerated Advanced Diplomas, only 1 program reported both hours and credits, thus omitted from figure 20. Diploma programs were the only credential that had all seven programs reporting both hours and credits. Only half the Advanced Diplomas and Degree programs were reported in figure 20. Advanced Diplomas was the credential that had the lowest discrepancies between hours and credits, while degrees and diplomas had similar amount of discrepancies when looking at the difference between hours and credits.

Supervision

In terms of practicum supervision, the number of agencies, students in practicum and faculty supervisors, along with supervisor credentials and frequency of contact were explored.

Number of Agencies, Students in Practicum and Faculty Supervisors

The number of agency partnerships ranged from 7 to over 200. There was between 5 to 285 students, regardless of whether it was their first practicum or a subsequent one and corresponded with the number of agency partners. Figure 21 is a breakdown by credential.

Only some Ontario Accelerated Advanced Diplomas and Advanced Diplomas specified among its roster of agency partners to have one in a school board setting explicitly. The way the number of students in practicum was reported was at times by semester and by practicum. The

number of faculty supervisors were either reported as whether they were full-time or part-time or by simply with the number.

Supervisor Credential

Of the 26 CYC programs that reported about credentials, there were some clarity concerns with exactly whose credential was reported; whether it was faculty or agency supervisors, but from what we observed, it appears to be faculty supervisors.

It was largely seen that faculty supervisors possessed one education level higher than what they were teaching.

Making up 78% of responses, the majority reported supervisors to either require a diploma or masters' degree (figure 22).

All part-time and casual staffers were either required

to have a CYC diploma, field experience or a combination of the two. Out of the ones

that required a diploma and bachelor, 6 diplomas and 1 bachelor required CYC experience.

All Accelerated Advanced Diplomas required supervisors to have a Diploma, whereas, Degree programs were the only credential that not indicate diplomas as sufficient qualification.

Degree and Diploma programs were the groups most likely to require a Masters degree (Figure 23).

One program was excluded as they use a website in place of a FW coordinator.

Other credentials that were indicated other than a Bachelor, Master's and Diploma, would be specific memberships (i.e. OACYC) or vague definitions such as as a qualified professional with knowledge and experience.

Contact Frequency

One key element to effective supervision is communication between student and supervisor. For CYC practicum, there are school supervisors and agency supervisors that students are required to be in contact with. The student's frequency of contact with school and agency supervisors ranged from daily to a set number of meetings and were fairly similar between the two groups, as seen in



Weekly contact was the most frequent response by participants and present in all credentials (figure 25).

- > Diplomas were the only group that indicated daily agency supervisor contact to be the most frequent response in contrast to weekly as indicated by most other groups.
- Both Accelerated Advanced Diplomas and Advanced Diplomas had indicated some agency supervisors had bi-weekly
- ➤ Whenever regular was indicated as a response, there was a lack of elaboration, and thus it is uncertain whether it was defined in the same way for all participants.

Evaluation

frequencies.

Evaluation not only involves the faculty supervisor but also, the agency supervisor and both had varying levels of involvement. In regards to the way practicum is evaluated, the majority were graded at 57%, 43% were either pass/fail or noted as satisfactory and unsatisfactory. Degrees were the

most inclined in grading practicum, in comparison to diplomas who were the least (figure 26).

The methods of evaluation include:

- > Evaluation forms completed by the students, faculty supervisor, agency supervisor or a combination of all three parties with either a midterm and a final evaluation or a final evaluation only.
- Presentations including interviews, case studies, research projects, of self, facilitations and meetings.
- Written Assignments reports, field projects, learning plans, workbooks, portfolios, observations, journal, logs, reflections.
- > Seminar.

Future research

This report has only skimmed the surface of our understanding of CYC field work in Canada. There are many characteristics that can be further explored to raise more awareness in CYC field work education practices. In regards to structure, our understanding of the relationship between hours and credit values is still rather limited. A more extensive analysis of these evaluation methods used in CYC practice would enable a more in-depth look at the assessment of CYC field work. It would be most interesting to see how such competencies are measured in relation to learning outcomes in course outlines, and standards that are set out by various associations across the country.
